End User License Agreement

## **Data Superhero Ltd. License and Service Agreement**

This agreement (the "Agreement") is a legal agreement between you, either an individual or a single legal entity ("You" or "you"), and Data Superhero Ltd. ("Data Superhero"). This Agreement governs your use of the Business Protect / Easy Backup Backup Client software distributed with this Agreement, including any updates that may be provided to you and any accompanying written documentation (the "Software") and the Business Protect / Easy Backup backup service ("Service").

### **PRIVACY AND COMMUNICATIONS**

You acknowledge and agree that Data Superhero may occasionally send you administrative and marketing communications regarding your account, the Service or promotional materials via email, mail, telephone and other communication mediums.

### **ACCOUNTS, PASSWORDS, AND SECURITY**

You must be a registered user to access the Service. You are responsible for keeping your password / encryption key secure. You will be solely responsible and liable for any activity that occurs under your user name. If you lose your password or the encryption key for your account, you may not be able to access your data. Data Superhero does not have a record of any encryption keys and cannot be held liable for loss of data due to password/encryption key problems.

### **ACCEPTABLE USE AND CONDUCT**

You are solely responsible for your conduct and your data related to the Service. You agree to indemnify, defend, and hold harmless Data Superhero and its suppliers from any and all loss, cost, liability, and expense arising from or related to your data, your use of the Service, or your violation of these terms.

The Software and Service are made available to you, your company, and/or your customers only for personal or commercial use, which use must be in compliance with all applicable laws, rules and regulations and must not infringe or violate third party rights.

## **CONSENT TO COLLECT NON-PERSONAL INFORMATION; USE OF DATA**

This information collected will be sent to Data Superhero and may be used by Data Superhero without restriction.

When you back up data via the Service, you agree that we and our service providers may copy and store such data as part of the Service.

## **CHANGES TO THE SERVICE AND TERMS AND CONDITIONS**

Data Superhero reserves the right at any time to modify, suspend, or discontinue providing the Service or any part thereof in its sole discretion with or without notice.

Data Superhero will use commercially reasonable efforts to notify you of modification, suspension, or discontinuance of the Service either by sending an email to the email address you provide with your registration or by a posting on DataSuperhero.com website. However, in no event will Data Superhero be liable to you or to any third party for any modification, suspension or discontinuance of the Service with or without notice.

Data Superhero reserves the right at any time to modify this Agreement in its sole discretion, without liability to you. This Agreement, as amended, will be effective upon acceptance of registration for new users and effective for all existing users 15 days after the posting of any amended terms on the DataSuperhero.com website. You agree that, upon such termination, you will destroy and permanently erase all copies of the Software and that your access rights to the Service will immediately terminate.

The terms of the Sections entitled Consent to Collect Non-Personal Information, Intellectual Property, Disclaimer of Warranties, Limitation of Liability, and Miscellaneous will survive expiration or termination.

If this Agreement terminates, other than for your failure to comply, Data Superhero will use commercially reasonable efforts to make your Data available for you to download for a period of three (3) days. Data Superhero has no obligation to provide you with a copy of your Data and may remove and discard any Data.

## **PAYMENT OF SERVICE FEES**

You shall pay the prescribed monthly fee for the Service within 30 days of receipt of an invoice and before the service term is scheduled to renew. You agree and acknowledge that the fee is determined by Data Superhero in reference to the amount of your data processed by Data Superhero and is subject to change as posted on the [datasuperhero.com](http://datasuperhero.com) website.
